EXCITING & BIG NEWS – The National Judges Cup

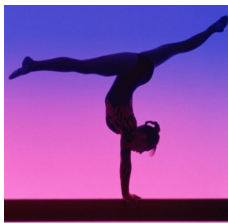
is being held in Portland, OR January 2018.
